**Sub.: A.P./NTR University of Health Sciences, Vijayawada - Recognition of M.D. (Microbiology) qualification in respect of students being trained at Gandhi Medical College, Secunderabad in respect of increased intake.**

Sir,

I am to state that the General Body of this council at its meeting held on 10.03.2007 considered the inspection report (June 2006) carried out to assess the standard of examination and other teaching facilities available at Gandhi Medical College, Secunderabad for purpose of recognition of M.D.(Microbiology) qualification granted by A.P./NTR University of Health Sciences, Vijayawada for the increased intake and the Council approved the following recommendations of Postgraduate Committee:

“The Postgraduate Committee considered the Council Inspector’s report (June,2006) and noted that Gandhi Medical College, Secunderabad already stands recognized for the award of M.D.(Microbiology) qualification with 2 (two) seats and now the matter is under consideration for recognition of the college against the increased intake; decided to recommend that M.D.(Microbiology) qualification granted by A.P./NTR University of Health Sciences, Vijayawada in respect of students being trained at Gandhi Medical College, Secunderabad be recognized against the increased intake restricting the number of admission to 4 (four) students per year.”
